CONSENT ORDER

The Louisiana Professional Engineering and Land Surveying Board [hereinafter the "Board"], by and through its Executive Director, pursuant to authorization by the Board, and Terry L. Hesseltine, P.E. [hereinafter "Respondent"] hereby agree to the following:

At all times material hereto, Respondent was licensed in the State of Louisiana as a professional engineer, number PE-36984. At all times material hereto, The Dimension Group I, LP [hereinafter "Dimension"], was licensed in the State of Louisiana as a professional engineering firm, number EF-5378; however, its license was in an expired status from April 1, 2020 through November 17, 2021. At all times material hereto, Respondent was an employee, representative and supervising professional of Dimension.

An investigation was opened based upon the Board's receipt of information and/or documents which suggested that Respondent may have committed violations of the Board's laws and/or rules. The investigation disclosed that between April 1, 2020 and November 17, 2021 (a) Dimension admittedly offered to provide engineering services in Louisiana and provided engineering services on nine (9) projects in Louisiana and (b) Respondent provided engineering services for and on behalf of Dimension in Louisiana in connection with said projects.

La. R.S. 37:698(A)(6), to wit LAC Title 46:LXI§2305(A)(3)(a), require supervising professionals of professional engineering firms to be responsible for renewal of the firm's license. La. R.S. 37:698(A)(9) and (16) prohibit the practicing and/or offering to practice engineering with an expired license. La. R.S. 37:698(A)(12) prohibits licensees from aiding or assisting another person in violating the laws and/or rules of the Board. La. R.S. 37:698(H) permits the Board to take disciplinary action against persons who violate La. R.S. 37:698(A)(6), to wit LAC

Title 46:LXI§2305(A)(3)(a), and La. R.S. 37:698(A)(12), upon a finding of guilt following the preferral of charges, notice and hearing and a majority vote of its entire membership authorized to participate in the proceeding. La. R.S. 37:698(A)(6), (9) and (16), La. R.S. 37:698(H) and LAC Title 46:LXI§2305(A)(3)(a) were in effect at all times material hereto.

It is undisputed that (a) at all times material hereto Respondent was licensed in Louisiana as a professional engineer, (b) at all times material hereto Dimension was licensed in Louisiana as a professional engineering firm; however, its license was in an expired status from April 1, 2020 through November 17, 2021, (c) at all times material hereto Respondent was an employee, representative and supervising professional of Dimension, (d) between April 1, 2020 and November 17, 2021 Dimension admittedly practiced and offered to practice engineering in Louisiana and (e) Respondent aided or assisted Dimension in violating the laws and/or rules of the Board.

By letter dated June 3, 2022, the Board gave notice to Respondent that it was considering the preferral of charges against Respondent on the grounds that Respondent may have violated (a) La. R.S. 37:698(A)(6), to wit LAC Title 46:LXI§2305, relative to supervising professionals of professional engineering firms being responsible for renewal of the firm's license, and (b) La. R.S. 37:698(A)(12), relative to aiding or assisting another person in violating the laws and/or rules of the Board.

Wishing to dispense with the need for further disciplinary action and to conclude the instant proceeding without further delay and expense, for the purpose of this proceeding only, Respondent and the Board do hereby enter into this Consent Order, in which Respondent of his own free will consents to the issuance of a Consent Order by the Board, wherein Respondent agrees to (a) pay a fine of One Thousand and No/100 (\$1,000.00) Dollars, (b) pay administrative costs of Six Hundred Seventy-Two and 71/100 (\$672.71) Dollars, (c) successfully complete the Board's online Louisiana Laws and Rules Quiz, (d) successfully complete the Board's online Louisiana Professionalism and Ethics Quiz, (e) the immediate suspension of his Louisiana professional engineer license if he fails to comply with any portion of this Consent Order, with said suspension continuing until he so complies, and (f) the publication of this Consent Order on the Board's website and a summary of this matter in the Board's official journal, the Louisiana

Engineer and Surveyor Journal, and the reporting of this matter to the National Council of Examiners for Engineering and Surveying (NCEES), identifying Respondent by name.

Respondent admits that his conduct as set forth above constitutes violations of the above referenced laws and/or rules as stated herein. Respondent acknowledges awareness of said laws and/or rules and states that he will comply with all applicable laws and rules henceforth. Respondent has been advised of his right to an informal conference, to be represented by counsel before the Board and/or to appear at any hearing personally or by counsel and present witnesses and evidence in his own behalf, he hereby waives this right and his right to appeal, and he states affirmatively that he has been afforded all administrative remedies due him under the law. Respondent further acknowledges awareness of the fact that the signed original of this Consent Order will remain in the custody of the Board as a public record and will be made available for public inspection and copying upon request.

Therefore, in consideration of the foregoing and by signing this Consent Order,

Respondent does hereby waive his right to an informal conference, to a hearing before the Board,
to the presenting of evidence and witnesses on his behalf, to Findings of Fact and Conclusions of
Law in this case, and to judicial review of this Consent Order.

Respondent hereby represents that (a) he fully understands the meaning and intent of this Consent Order, including but not limited to its final and binding effect, (b) he has voluntarily entered into this Consent Order and that no other promise or agreement of any kind has been made to or with him by any person whatsoever to cause the execution of this instrument and (c) the sanctions set forth in this Consent Order do not prevent the Board from taking further disciplinary or enforcement action against Respondent on matters not specifically addressed in this Consent Order.

WHEREFORE, the Louisiana Professional Engineering and Land Surveying Board and Respondent agree that:

 Respondent shall pay a fine of One Thousand and No/100 (\$1,000.00) Dollars, which shall be tendered to the Board by certified check payable to the Board, due upon the signing of this Consent Order; and

2. Respondent shall pay administrative costs of Six Hundred Seventy-Two and 71/100 (\$672.71) Dollars, which shall be tendered to the Board by certified check payable to the Board, due upon the signing of this Consent Order; and

3. Respondent shall successfully complete the Board's online Louisiana Laws and Rules Quiz with a score of 90% or higher and return it to the Board within sixty (60) days of the

effective date of this Consent Order; and

Respondent shall successfully complete the Board's online Louisiana 4.

Professionalism and Ethics Quiz with a score of 90% or higher and return it to the Board within

sixty (60) days of the effective date of this Consent Order; and

Respondent's Louisiana professional engineer license, number PE-36984, shall be

immediately suspended if he fails to comply with any portion of this Consent Order, with said

suspension continuing until he so complies; and

This Consent Order shall be published on the Board's website and a summary of

this matter shall be printed in the official journal of the Board, the Louisiana Engineer and

Surveyor Journal, and reported to the National Council of Examiners for Engineering and

Surveying (NCEES), identifying Respondent by name; and

This Consent Order shall not become effective unless and until it is accepted and

signed by and on behalf of the Board. Should the Board not accept and sign this Consent Order,

it is agreed that presentation of this matter to the Board shall not prejudice the Board or any of its

members, staff, attorneys or representatives from further participation, consideration, or

resolution of any further proceedings herein.
