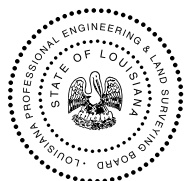

Message from the Chairman

Terry Huval, P.E.

As the newest Chair of the Louisiana Professional Engineer and Land Surveyors Board (LAPELS), it is a privilege to share some of my thoughts with the engineering and land surveying professionals of our state.

Quoting from the Louisiana Revised Statutes, the main role of LAPELS is to do all it can "to safeguard life, health, and property and to promote the public welfare", specifically as it applies to engineering and land surveying. Sounds straight forward enough...

1. From a macro perspective, our profession is a noble one. We help create and maintain great communities. Every part of public and private infrastructure is a result of fundamental and imaginative engineering talent. Ours is a profession that builds things to last and that improves the lives of people. I know that each one of you take pride of the outcome of your work. It is that pride of a job well-done that is the driver of good engineering and land surveying work.
2. As professionals, we are trusted members in our communities. Many people, in very differing walks of life, look to our opinions on matters that affect the community, as a whole. Many of these matters may not involve much, if any, engineering-related topics. Often, people trust the opinions of engineers and land surveyors because engineering is strongly based on logical thinking. While members of our profession can choose to be more aggressive, and others are less aggressive, in their pursuits in their communities, there is no question that each can have an important role in the aspects of community-life that they hold most dear. I encourage you to be aware of your responsibilities as a citizen and to try to do what is right for your community, no matter who benefits the most. When we act in this way, we maximize our trustworthiness in our community and in our profession.
3. In the administration of our Board responsibilities over the decades, initial "rules" were developed to guide the Board and the profession. Consistent with the history of human nature,

new rules have had to be put in place to address activities by some who chose to compromise our main role "to safeguard... the public welfare". More specifically, because a very

small part of our profession has found ways to bend the rules, either for their own benefit or for the benefit of their clients, our Board has had to remain vigilant to make the rules as precise as possible to avoid such mischief. If the Board did not take such action, there would be harm to the public, in addition to tarnishing our profession.

4. We must always remember that the profit motive, while an important part of our respective businesses, can never come at the expense of "Safeguarding the Public Welfare". Those who see it differently are setting themselves up to providing a disservice to themselves, our profession and our overall society. I, and the other members of the Board, ask each of you to take these points in strong consideration as you exercise your role as a professional engineer and/or land surveyor.

In closing, during my tenure on the Board, I have personally reviewed a large number of applications for licensure where the applicants have taken pride in their respective engineering experiences. They are already spreading their wings to serve their communities with a strong focus on their larger role "to safeguard life, health, and property and to promote the public welfare".

I congratulate them, and all of you, as we all reach out for a better future.

Disciplinary and Enforcement Actions

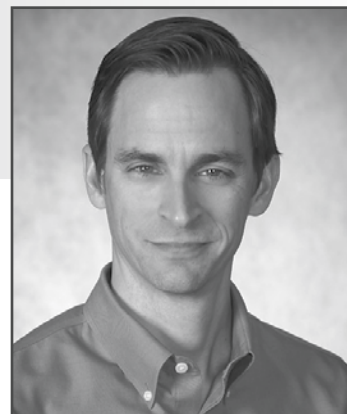
The Board continues to investigate alleged violations of the laws and rules which regulate the practice of engineering and land surveying in Louisiana. Substantiated violations result in disciplinary or enforcement action being taken either through a Consent Order or by Board Decision following a formal hearing at which the respondent is adjudged guilty of one or more violations. Below is a summary of the disciplinary/enforcement actions taken by the Board since the previous issue of the Journal.

SEALING VIOLATIONS:

Elmer Jones, P.E., a professional engineer (PE-17246), was subject to disciplinary action by the Board for (a) failing to seal and sign engineering documents that have been issued by the licensee to a client or any public or governmental agency as completed work in violation of La. R.S. 37:698(A)(6), to wit LAC Title 46:LXI\$2701(A)(4)(a)(i), and (b) failing to place the appropriate disclaimer on preliminary documents, along with the licensee's name and license number, in violation of La. R.S. 37:698(A)(6), to wit LAC Title 46:LXI\$2701(A)(4)(b)(i). In 2015 Mr. Jones prepared and provided to his client some preliminary engineering plans in connection with the construction of a shopping center in Louisiana which did not contain the requisite preliminary work disclaimer and his name and license number. In 2015 Mr. Jones also prepared and provided to his client and a city permit department some completed engineering plans in connection with the same project which did not contain his Louisiana professional engineer seal and signature. Mr. Jones has entered into a Consent Order with the Board, wherein he admitted to the referenced violations of the above laws/rules and agreed to pay a fine of \$1,000; to pay administrative costs of \$1,995.34; to successfully complete the Board's online Louisiana Laws and Rules Quiz; to successfully complete the Board's online Louisiana Professionalism and Ethics Quiz; to place the appropriate disclaimer on all preliminary documents, along with his name and license number; to seal and sign all engineering documents which he issues to a client or governmental agency as completed work unless specifically exempted by applicable law or rule; and to the publication of the Consent Order on the Board's website, the printing of a summary of this matter by name in this publication, and the reporting of this matter by name to NCEES.

EJA Partners, L.L.C., a professional engineering firm (EF-4613), was subject to disciplinary action by the Board for having a representative who (a) failed to seal and sign engineering documents

that have been issued by the licensee to a client or any public or governmental agency as completed work in violation of La. R.S. 37:698(C), to wit La. R.S. 37:698(A)(6) and LAC Title 46:LXI\$2701(A)(4)(a)(i), and (b) failed to place the appropriate disclaimer on preliminary documents, along with the licensee's name and license number, in violation of La. R.S. 37:698(C), to wit La. R.S. 37:698(A)(6) and LAC Title 46:LXI\$2701(A)(4)(b)(i). Elmer Jones, P.E. was the supervising professional, owner, manager and an employee of the firm. In 2015 the firm and Mr. Jones prepared and provided to their client some preliminary engineering plans in connection with the construction of a shopping center in Louisiana which did not contain the requisite preliminary work disclaimer and Mr. Jones' name and license number. In 2015 the firm and Mr. Jones also prepared and provided to their client and a city permit department some completed engineering plans in connection with the same project which did not contain Mr. Jones' Louisiana professional engineer seal and signature. The firm has entered into a Consent Order with the Board, wherein it admitted to the referenced violations of the above laws/rules and agreed to pay a fine of \$1,000; to pay administrative costs of \$1,995.34; to have its supervising professional successfully complete the Board's online Louisiana Laws and Rules Quiz and online Louisiana Professionalism and Ethics Quiz; to ensure that its professional engineers place the appropriate disclaimer on all preliminary documents, along with their name and license number; to ensure that its professional engineers seal and sign all engineering documents which they issue to a client or governmental agency as completed work unless specifically exempted by applicable law or rule; and to the publication of the Consent Order on the Board's website, the printing of a summary of this matter by name in this publication, and the reporting of this matter by name to NCEES.

Christopher K. Richard, P.E., Appointed to LAPELS Board

Governor Edwards has appointed Chris Richard, P.E., to the Louisiana Professional Engineering and Land Surveying Board. Chris will serve a six-year term on the Board as a Professional Engineer representing Private Practice. Chris has thirty years of practice in the field of civil engineering, twenty-nine of which are in the field of private practice in consulting engineering.

Chris was born in Houston, Texas, raised in Lafayette, Louisiana, and graduated from the University of Louisiana at Lafayette, formerly the University of Southwestern Louisiana, in 1987 with a Bachelor of Science degree in Civil Engineering. His father, Donald Richard, was a civil engineer with the firm of Domingue, Szabo, and Associates, Inc. (DSA), and later became the President of that company.

Chris began his career with the Louisiana Department of Transportation and Development, in the Road Design section in Baton Rouge. In 1988, he moved to Sarasota, Florida, after accepting a position with Bishop and Associates consulting engineering firm. He worked on water system projects during his tenure there. In 1991, he was offered a position with DSA, where he was able to work with his father until his father's retirement in 2007. Chris is a part owner of DSA and serves as Chairman of the Board and Chief Engineer. Chris has extensive experience in water distribution and treatment systems and wastewater collection and treatment systems, and serves as the engineer for the Lafayette Economic Development Authority and city engineer for the City of Breaux Bridge, Louisiana. He is a licensed Professional Civil and Environmental Engineer in Louisiana and a licensed Professional Engineer in Florida.

Chris has served the engineering profession in many capacities over the decades. He served the Lafayette Chapter of the Louisiana Engineering Society as President, and served in all officer positions of the Louisiana Engineering Society (LES), culminating in his Presidency in 2005-2006. He served as the President of the Louisiana Engineering Foundation from 2006-2008 and Lafayette Chapter President of ACEC/L. He holds memberships in the National Society of Professional Engineers, the American Society of Civil Engineers, the Water Environment Federation and the Ameri-

can Water Works Association.

Chris is currently serving on the UL Alumni Council Executive Board, and has served his community through Our Lady of Fatima Church and School, as a volunteer at the church and for the Project Charlie program. He also completed the Leadership Lafayette program, graduating in 2003. He serves as a mentor for the UL Civil Engineering Senior Design class.

Chris's honors include the Outstanding Young Civil Engineer Award from the Louisiana Section of the American Society of Civil Engineers in 1995, the F. Hugh Coughlin Award of Merit for Young Engineers from LES in 1998, the Waldemar S. Nelson President's Award from LES, which he received twice, and the Hixson/Price National Professional Achievement Award from LES. He was named a Fellow of the National Society of Professional Engineers in 2012.

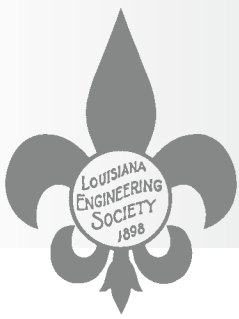

I personally love this time of year. It's the time of the year when we Louisianans get a reprieve from the hot humid weather and potentially experience a much cooler forecast. The weather in 2017 has not been favorable to many of our friends and family members in our region of the country. On behalf of our organization, I want to extend our thoughts and prayers to all those who have suffered during this storm season and extend our many blessings to them in their recovery efforts. In times such as these, our profession has a unique opportunity to truly help the public and assist in implementing positive change within the community infrastructure to ensure future disaster impacts will not be as severe or even realized.

In the spirit of change, our organization is also undergoing some significant modifications within its own right. On September 8, 2017 an LES Board of Direction Meeting was held in Shreveport, LA. While many issues were discussed, the majority of the delegation's time was spent deliberating the new NSPE business model that was presented in July of this year. After careful consideration, the LES Board of Direction voted to notify NSPE that it elected to be classified as a "non-integrated state". In summary, a non-integrated state will be responsible for the management of its own membership which LES has historically accomplished since its inception in 1898. As a result of said vote and effective immediately, LES members now have a choice in their membership affiliation with NSPE. Previously, LES members were required to become NSPE members and pay \$239 annually (\$85 LES + \$154 NSPE). Under the new non-integrated model, LES members have the choices of joining LES Only (\$95), NSPE Only (\$110 new members/\$154 renewing members) or LES and NSPE Jointly (\$205 new members/\$249 renewing members). Also under the new model, NSPE has elected to increase membership dues to \$299 in July 2018. As a result of these changes, a member could elect to participate in LES only at an annual cost of \$95.

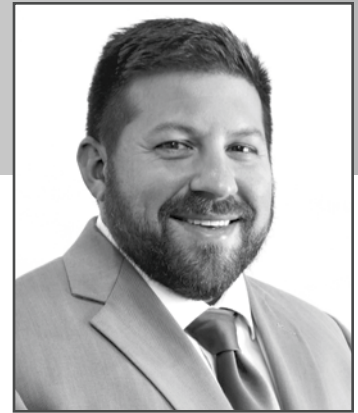
Recently, I had the opportunity to attend Licensing Ceremonies in Shreveport and Monroe respectively.

We encourage early registration and look forward to the diverse and informative program our committee is putting together; see program agenda in this issue.

In closing, I appreciate everyone's assistance in helping our organization continue to be an important member of our respective communities. I believe I speak for the rest of the board when I say that our doors are always open to anyone with any concerns and offer our assistance when possible. May God bless all and pray everyone enjoy a safe and joyous holiday season.

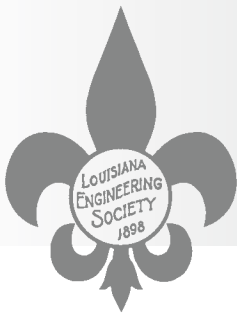

Louisiana Professional Engineers and Land Surveying (LAPELS) was established in 1908, and is the second oldest licensing board of its kind in the country. For over 100 years, the LAPELS Board has worked to "safeguard life, health, and property and to promote public welfare" through regulating licensure of Professional Engineers and Land Surveyors in the State of Louisiana.

The LAPELS Board has eleven members, nine who are licensed Professional Engineers and two who are licensed Professional Land Surveyors. There are two members representing each of the engineering practice divisions of private practice, government, education, and industry, and one member representing construction. Board members serve a six year term, with the terms of no more than two members expiring each year. The term of one LAPELS Board member representing Professional Engineers in Industry will be expiring on March 31, 2018.

As Chairman of the PE's in Industry practice division of Louisiana Engineering Society (LES), I am charged with presenting qualified candidates to the LES State Board to fill the LAPELS Board

vacancy representing my practice division. The LES Board will subsequently submit five (5) nominees to the Governor, who will make the final appointment to the LAPELS Board.

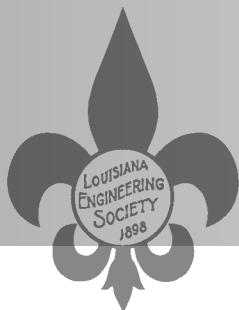

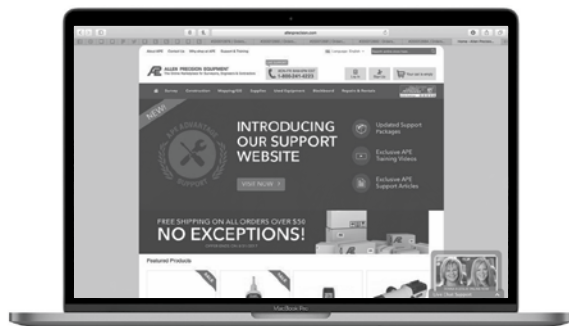

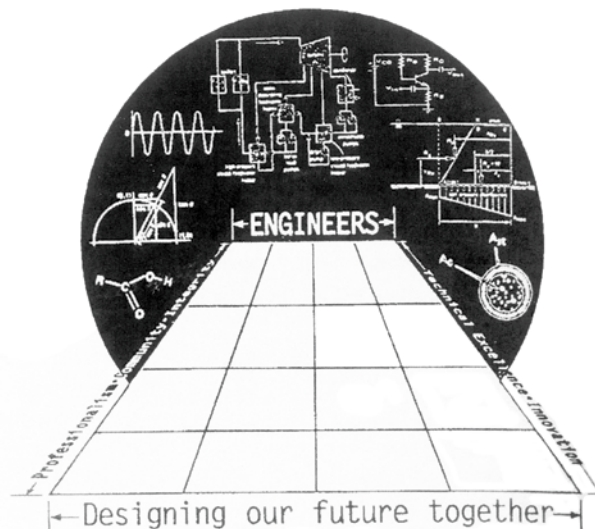

Capitol View: from Haynie and Associates

The Louisiana Legislature may be home for the fall and holiday season but regrettably, few will be cheerful upon their return to Baton Rouge. Predictably, the 2018 fiscal cliff is coming and the state lawmakers will have to find a way to close a \$1.5 billion shortfall before June 30th 2018. During the 2017 Fiscal Session that ended in June, Governor Edwards and the legislature unsuccessfully explored and debated new forms of revenues to replace the temporary extra penny of sales tax, with little success, forcing a special session early next year.

Currently Governor John Bel Edwards (D) and House Speaker Taylor Barras (R) are traveling Louisiana for meetings with community business leaders and state legislators to find a consensus solution before calling for a Legislative Special Session in early 2018. A bipartisan group of legislators has been meeting and attending retreats to try to forge a compromise.

One possible solution is the continuation of the fifth penny of sales tax (or part of the penny) either on a short-term basis or permanently. Many legislators of both parties are not satisfied with this solution, which would leave Louisiana with the highest sales tax in the nation. Legislators are working to find a more reform minded approach such as expanding the tax base, reducing exemptions, credits and incentives; and reducing the current itemized and federal deductions. The prediction of legislative leaders are that if enough legislators can agree to a solution by February of 2018 a special session will be called following Louisiana Mardi Gras and prior to the Legislative Regular Session, which runs March 12 – June 4, 2018. If no new revenues are found prior to March 12, because the regular session cannot deal with fiscal matters, an emergency special session would have to be called the last three weeks in June with a short window to find a solution before the fiscal cliff.

It is no secret that Louisiana's transportation issues have taken a back seat to the Louisiana budget. While the Transportation, Highways and Public Works Committee tours the state, the public and business outcry for transportation improvement is loud and clear. More dollars are needed for infrastructure but the timing and politics simply do not appear to be there to pass a gas tax either through the legislature or by public vote. It is our prediction that after the budget is stabilized, the state legislators will be able to focus more of their attention on transportation funding.

On October 14th, Louisiana citizens took to the polls and voted to amend the 1974 Louisiana State Constitution with Constitutional Amendment 3. Amendment 3 protects funding for transportation construction projects and creates a restriction on the way any future gasoline and fuel taxes can be used. Funds will only be available to pay for transportation construction projects. Passing of Amendment 3 could spur renewed efforts and increase confidences to raise new gasoline or fuel tax in 2018 or 2019. Constitutional Amendment 1 also passed, a great win for business and industrial growth, ensuring continued property tax exemption for projects under construction. Other significant Primary Election results is the run-off for New Orleans Mayor between LaToya Contrell and Desiree

Charbonnet, both Democrats and the run-off for Louisiana State Treasurer between State Representative John Schroder (R) and Derrick Edwards (D). We encourage you to vote in the Statewide General election on November 18th.

Furthermore, the Fiscal Year 2017-2018 DOTD Capital Outlay/ Non-State Statutory Dedications Recommended funding for State Highway Improvement is \$58,000,000. This recommendation estimates project expenditures based upon projected available revenue sources. The administration is being very cautious to bond out additional dollars until the fiscal cliff shortfall is addressed.

As always we suggest you take this time when legislators are not in session to reach out to them, simply offer them a cup of coffee or a sandwich, get to know them and let them know what you do and discuss the LES mission. It is always best to form relationships in good times that way if we need you to call on them during a session the relationship is already built. The 2018 regular session will allow unlimited general subject matter bills, and as always, we will keep you advised on any legislation that may affect the engineering profession.


