Public service was not the career path that I had intended and being an engineer in public service requires a certain skill set that isn't necessarily one that comes naturally, at least not for me. UNLICENSED OFFER AND/OR PRACTICE OF ENGINEERING OR LAND SURVEYING:

John Beath Environmental LLC, an unlicensed firm which subsequently became licensed as a professional engineering firm effective October 4, 2021 (EF-7178), was subject to enforcement action by the Board for practicing engineering without proper licensure in violation of La. R.S. 37:681 and La. R.S. 37:700(A)(1) and (9), to wit LAC Title 46:LXI§2301(B). Between approximately September 2016 and September 2021 the firm admittedly provided engineering services on ten projects in Louisiana. The firm has entered into a Consent Order with the Board, wherein it admitted to the referenced violations of the above laws/rules and agreed to pay a fine of \$3,000; to pay administrative costs of \$546.77; and to the publication of the Consent Order on the Board's website, the printing of a summary of this matter by name in this publication, and the reporting of this matter by name to NCEES.

John M. Beath, an unlicensed individual, was subject to enforcement action by the Board for practicing engineering without proper licensure in violation of La. R.S. 37:681 and La. R.S. 37:700(A)(1). During the period beginning September 2016 and ending September 2021 Mr. Beath admittedly provided engineering services on ten projects in Louisiana. Mr. Beath has entered into a Consent Order with the Board, wherein he admitted to the referenced violations of the above laws/rules and agreed to pay a fine of \$1,500; to pay administrative costs of \$546.77; to cease and desist practicing and offering to practice engineering and using the words "engineer", "engineering", "P.E.", "professional engineer" or modifications or derivatives thereof to describe himself, his professional credentials or his services in Louisiana until such time as he is duly licensed by the Board, except as may otherwise be permitted by La. R.S. 37:702; and to the publication of the Consent Order on the Board's website, the printing of a summary of this matter by name in this publication, and the reporting of this matter by name to NCEES.

AMMTEC Consultants PLLC, an unlicensed firm which subsequently became licensed as a professional engineering firm in Louisiana effective June 25, 2020 (EF-6874), was subject to enforcement action by the Board for practicing and/or offering to practice engineering in Louisiana without proper licensure in violation of La. R.S. 37:700(A)(1) and (9), to wit LAC 46:LXI§2301(B). Between July 2017 and May 2019 the firm admittedly offered to provide engineering services in Louisiana and provided engineering services on 10 projects in Louisiana. The firm has entered into a Consent Order with the Board, wherein it admitted to the referenced violations of the above laws/rules and agreed to pay a fine of \$3,000; to pay administrative costs of \$246.96; and to the publication of the Consent Order on the Board's website, the printing of a summary of this matter in the Board's official Journal, and the reporting of this matter to NCEES, identifying Respondent by name in

each publication.

Smith Emery Laboratories, Inc.

an unlicensed firm which subsequently became licensed as a professional engineering firm effective October 11, 2023 (EF-7668), was subject to enforcement action by the Board for practicing and/or offering to practice engineering without proper licensure in violation of La. R.S. 37:681 and La. R.S. 37:700(A)(1) and (9), to wit LAC Title 46:LXI§2301(B). On

or about February 23, 2023 the firm admittedly offered to provide engineering services on one project in Louisiana. The firm has entered into a Consent Order with the Board, wherein it admitted to the referenced violations of the above laws/rules and agreed to pay a fine of \$3,000; to pay administrative costs of \$501.23; and to the publication of the Consent Order on the Board's website, the printing of a summary of this matter by name in this publication, and the reporting of this matter by name to NCEES.

DBR Engineering Consultants, Inc., an unlicensed firm which subsequently became licensed as a professional engineering firm effective August 17, 2023 (EF-7631), was subject to enforcement action by the Board for practicing and/or offering to practice engineering without proper licensure in violation of La. R.S. 37:681 and La. R.S. 37:700(A)(1) and (9), to wit LAC Title 46:LXI§2301(B). Between at least April 2021 and August 2023 the firm admittedly provided and offered to provide engineering services on at least two projects in Louisiana. The firm has entered into a Consent Order with the Board, wherein it admitted to the referenced violations of the above laws/rules and agreed to pay a fine of \$3,000; to pay administrative costs of \$418.50; and to the publication of the Consent Order on the Board's website, the printing of a summary of this matter by name in this publication, and the reporting of this matter by name to NCEES.

AIDING OR ASSISTING ANOTHER PERSON IN VIOLATING THE LAWS/RULES OF THE BOARD:

unlicensed practice of and/ or offer to practice engineering on 10 projects in the state of Louisiana. Mr. Money was an officer, employee and representative of the firm. Mr. Money has entered into a Consent Order with the Board, wherein he admitted to the referenced violations of the above laws and agreed to pay a fine of \$500; to pay administrative costs of \$246.96; to successfully complete the Board's online Louisiana Laws and Rules Quiz and Louisiana Professionalism and Ethics Quiz with a score of 90% or higher on each; and to the publication of the Consent Order on the Board's website, the printing of a summary of this matter by name in the Board's official Journal, and the reporting of this matter to NCEES, identifying Respondent by name in each publication.

Noel K. Clary, P.E., a professional engineer (PE-23299), was subject to disciplinary action by the Board for aiding or assisting the firm where he served as supervising professional in violating the laws and/or rules of the Board in violation of La. R.S. 37:698(A)(12). Between October 1, 2018 and October 17, 2023 **(a)** Allied Engineering Design, LLC admittedly provided engineering services in Louisiana on 21 projects in Louisiana and **(b)** Mr. Clary provided engineering services for and on behalf of the firm in Louisiana in connection with said projects; and **(c)** Mr. Clary was an employee, manager, and representative of the firm, and is the supervising professional of the firm. Mr. Clary has entered into a Consent Order with the Board, wherein he admitted to violations of the above laws/rules and agreed to pay a fine of \$500; to pay administrative costs of \$182.05; to successfully complete the Board's online Louisiana Laws and Rules Quiz and Louisiana Professionalism and Ethics Quiz with a score of 90% or higher on each; and to the publication of the Consent Order on the Board's website, the printing of a summary of this matter by name in this publication, and the reporting of this matter by name to NCEES.

Kenneth L. Roland, P.E., a professional engineer (PE-42427), was subject to disciplinary action by the Board for aiding or assisting another person in violating the laws and/or rules of the Board in violation of La. R.S. 37:698(A)(12). Between at least April 2021 and August 2023 **(a)** DBR Engineering Consultants, Inc. (an unlicensed firm which subsequently became licensed as a professional engineering firm) admittedly provided and offered to provide engineering services on at least two projects in Louisiana and **(b)** Mr. Roland provided engineering services for and on behalf of the firm in Louisiana in connection with said projects. Mr. Roland was an officer, employee and representative of the firm and is now the supervising professional of the firm. Mr. Roland has entered into a Consent Order with the Board, wherein he admitted to the referenced violations of the above laws/rules and agreed to pay a fine of \$500; to pay administrative costs of \$418.50; to successfully complete the Board's online Louisiana Laws and Rules Quiz and Louisiana Professionalism and Ethics Quiz; to the immediate suspension of his license if he fails to comply with any portion of the Consent Order, with said suspension continuing until he so complies; and to the publication of the Consent Order on the Board's website, the printing of a summary of this matter by name in this publication, and the reporting of this matter by name to NCEES.

R.S. 37:700(A)(3). Prior to June 2022 the firm admittedly offered to provide engineering services in Louisiana and provided engineering services on at least one project in Louisiana. In June 2022 the firm submitted to the Board an application for engineering firm licensure which falsely stated that the firm had never practiced or offered to practice engineering in Louisiana. Between June 2022 and August 2022 the firm admittedly continued to offer to provide engineering services in Louisiana and provide engineering services on at least one project in Louisiana. The firm has entered into a Consent Order with the Board, wherein it admitted to the referenced violations of the above laws/rules and agreed to pay a fine of \$3,750; to pay administrative costs of \$1,521.62; and to the publication of the Consent Order on the Board's website, the printing of a summary of this matter by name in this publication, and the reporting of this matter by name to NCEES.

Michael D. Clark, P.E., a professional engineer (PE-25050), was subject to disciplinary action by the Board for **(a)** fraud, deceit, material misstatement or perjury, or the giving of any false or forged evidence, in applying for a license with the Board in violation of La. R.S. 37:698(A)(1) and **(b)** aiding or assisting another person in violating the laws and/or rules of the Board in violation of La. R.S. 37:698(A)(12). Prior to June 2022 **(a)** Winkelmann & Associates, Inc. (an unlicensed firm which subsequently became licensed as a professional engineering firm) admittedly offered to provide engineering services in Louisiana and provided engineering services on at least one project in Louisiana and **(b)** Mr. Clark provided engineering services for and on behalf of the firm in Louisiana in connection with said project(s). In June 2022 Mr. Clark signed and submitted to the Board on behalf of the firm an application for engineering firm licensure which falsely stated that the firm had never practiced or offered to practice engineering in Louisiana. Between June 2022 and August 2022 **(a)** the firm admittedly continued to offer to provide engineering services in Louisiana and provide engineering services on at least one project in Louisiana and **(b)** Mr. Clark provided engineering services for and on behalf of the firm in Louisiana in connection with said project(s). Mr. Clark was the President and a representative of the firm and is now the supervising professional of the firm. Mr. Clark has entered into a Consent Order with the Board, wherein he admitted to the referenced violations of the above laws/rules and agreed to pay a fine of \$1,500; to pay administrative costs of \$1,521.62; to successfully complete the Board's online Louisiana Laws and Rules Quiz and Louisiana Professionalism and Ethics Quiz; to the immediate suspension of his license if he fails to comply with any portion of the Consent Order, (Continued)

with said suspension continuing until he so complies; and to the publication of the Consent Order on the Board's website, the printing of a summary of this matter by name in this publication, and the reporting of this matter by name to NCEES.

EXPIRED PRACTICE:

George A. Evans, P.L.S., a professional land surveyor (PLS-4750), was subject to disciplinary action by the Board for providing land surveying services in Louisiana while his Louisiana professional land surveying license was expired in violation of La. R.S. 37:698(A)(9) and (16). Mr. Evans entered into a Consent Order with the Board, admitting guilt that his conduct violated La. R.S. 37:698(A)(9) and (16); and agreed to pay a fine of \$1,000 and administrative costs of \$183.82; and agreed to successfully complete the Board's online Louisiana Laws and Rules Quiz and Louisiana Professionalism and Ethics Quiz with a score of 90% or higher on each; and agreed to the publication of the Consent Order on the Board's website, the printing of a summary of this matter in the Board's official Journal, and to the reporting of this matter to NCEES, each time identifying Respondent by name.

Gabriel S. Arias, P.E., a professional engineer (PE-42599), was subject to disciplinary action by the Board for providing engineering services in Louisiana while his Louisiana professional engineering license was expired in violation of LR.S. 37:681 and La. R.S. 37:698(A)(9) and (16). Mr. Arias entered into a Consent Order with the Board, admitting violations of La. R.S. 37:698(A)(9) and (16); and agreed to pay a fine of \$1,000 and administrative costs of \$156.77; and agreed to successfully complete the Board's online Louisiana Laws and Rules Quiz and Louisiana Professionalism and Ethics Quiz with a score of 90% or higher on each; and agreed to the publication of the Consent Order on the Board's website, the printing of a summary of this matter in the Board's official Journal, and to the reporting of this matter to NCEES, each time identifying Respondent by name.

Allied Engineering Design, LLC, a licensed engineering firm (EF-4557), was subject to disciplinary action by the Board for practicing engineering while in expired status in violation of La. R.S. 37:681 and La. R.S. 37:698(A)(9) and (16). Allied Engineering Design, LLC has entered

into a Consent Order with the Board, wherein it admitted providing engineering services in Louisiana on 21 projects while its license was in an expired status from October 2018 to October 2023, and admitted violations of La. R.S. 37:681 and La R.S. 37:698(A)(9) and (16) and agreed to pay a fine of \$5000; to pay administrative costs of \$182.05; and to the publication of the Consent Order on the Board's website, the printing of a summary of this matter by name in this publication, and the reporting of this matter by name to NCEES.

Gary A. Storm, P.E., a professional engineer (PE-32775), was subject to disciplinary action by the Board for practicing and/or offering to practice engineering with an expired license in violation of La. R.S. 37:698(A)(9) and (16). Between April 2023 and November 2023 Mr. Storm admittedly offered to provide engineering services in Louisiana and provided engineering services on five projects in Louisiana. Mr. Storm has entered into a Consent Order with the Board, wherein he admitted to the referenced violations of the above laws/rules and agreed to pay a fine of \$1,000; to pay administrative costs of \$694.13; to successfully complete the Board's online Louisiana Laws and Rules Quiz and Louisiana Professionalism and Ethics Quiz; to the immediate suspension of his license if he fails to comply with any portion of the Consent Order, with said suspension continuing until he so complies; and to the publication of the Consent Order on the Board's website, the printing of a summary of this matter by name in this publication, and the reporting of this matter by name to NCEES.

REVIEW OF CONTINUING PROFESSIONAL DEVELOPMENT (CPD) FOR LOUISIANA-LICENSED ENGINEERS AND LAND SURVEYORS

Continuing professional development is a program to ensure that all individual licensees of the LAPELS Board are informed of those technical and professional subjects necessary to safeguard life, health and property and promote the public welfare, Chapter 31 of the Board Rules. The current CPD program requires every professional engineer to earn 15 professional development hours (PDHs) per calendar year in engineering-related

acceptable activities, and every professional land surveyor to earn 8 PDHs per calendar year. At least one of the PDHs per calendar year shall be earned in professional ethics. For more information and further details, you can refer to the Board Rules, Title 46 Professional and Occupational Standards, Part LXI. Professional Engineers and Land Surveyors. The Board Laws and Rules are readily available on the LAPELS website, <https://lapels.com/LawsRules.html>.

From time-to-time at various conferences and meetings, the Board has been asked to consider reducing CPD requirements based upon age and/or years licensed. In 2023, Chairman Benoit appointed an ad-hoc committee to review CPD requirements for engineers and land surveyors. The committee was comprised of myself as chair, Jimmy Chustz, Janice Williams, and Reggie Jeter. This committee met along with LAPELS Executive Director, Donna Sentell, in February 2024. Discussions for and against took place. Additionally, the other NCEES jurisdictions were informally polled on whether or not they reduce CPD hours based upon age. Of the responding jurisdictions, 83% stated that no, they do not. Approximately 1/3 of the 69 total jurisdictions responded. It was decided to recommend to the Board by this committee to not pursue changes to the CPD requirements. The Board voted in favor of this recommendation at the February 27, 2024 meeting, and therefore at this time there are no changes in CPD requirements for professional engineers and professional land surveyors.

This recurring subject brings another important aspect of licensure with LAPELS to light: licensure status. Options are available to exempt CPD requirements for the licensee who no longer will be practicing or offering to practice engineering or land surveying. From the Board Rules Chapter 21:

Retired Status is the licensure status which exists for an individual licensee of the board who has chosen not to practice or offer to practice engineering and/or land surveying in Louisiana and who has either elected to be in this status on his/her biennial licensure renewal form or otherwise received authorization from the board to be in this status. To qualify for the retired status, the licensee must be at least 70 years of age or have been a licensee of the board for at least 35 years. Unless the licensee is granted a waiver by the board, the renewal fee for the retired status shall be one-half of the current renewal fee for the active status. A licensee qualified for the retired status may be granted a waiver of this renewal fee if the licensee is at least 70 years of age, has been a licensee of the board for at least 35 years continuously, has never been subject to disciplinary action in any jurisdiction, has never committed any of the offenses described in R.S. 37:698(A)(3), (4) or (5), and is of good character and reputation. A licensee in a retired status can represent himself/herself to the public as a P.E. retired or a P.L.S. retired, as applicable, but cannot otherwise practice or offer to practice engineering and/or land surveying in Louisiana. A licensee in a retired status may apply to the board to reactivate the retired license to active status.

Inactive Status is the licensure status which exists for an individual licensee of the board who has chosen not to practice or offer to practice engineering and/or land surveying in Louisiana and who has either elected to be in this status on his/her biennial licensure renewal form or otherwise received authorization from the board to be in this status. A licensee in an inactive status can represent himself/herself to the public as a P.E. inactive or a P.L.S. inactive, as applicable, but cannot otherwise practice or offer to practice engineering and/or land surveying in Louisiana. A licensee in an inactive status may apply to the board to reactivate the inactive license to active status.

In the event a licensee in the Retired Status or in the Inactive Status elects to reactivate his/her license to active status, he/she must meet the requirements for CPD Reactivation set forth in §3121 of the Board Rules.

I hope that those who are reading this summary appreciate the concerted effort the Board has made to consider reducing CPD requirements for active licensees. It is with the utmost consideration to safeguard life, health and property and to promote the public welfare that the Board is not making changes at this time.

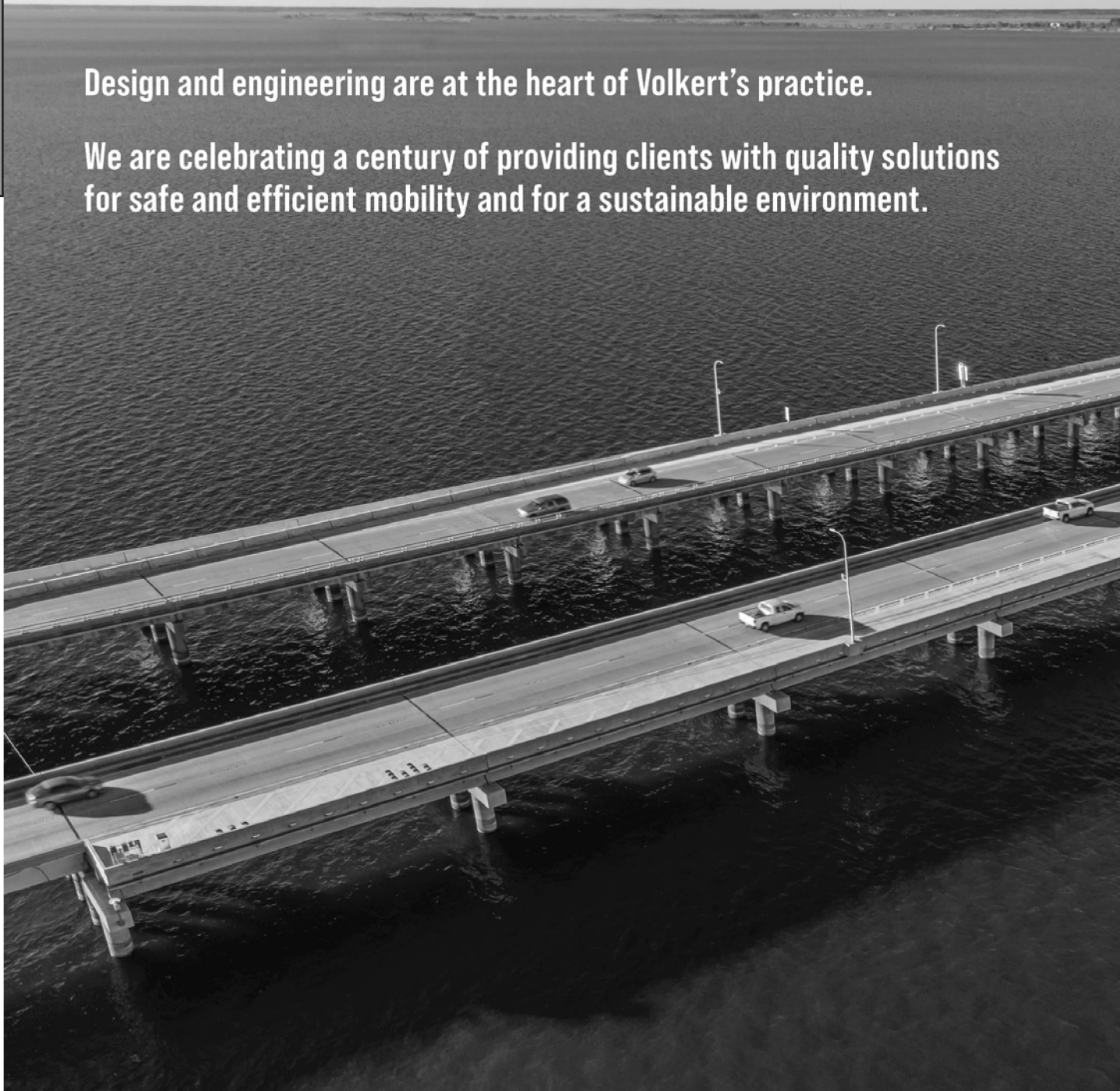

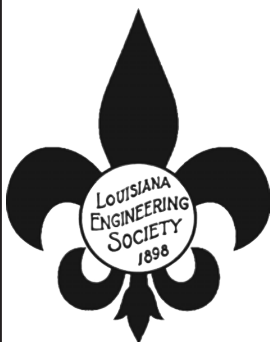

2024 Legislative Session

The 85-day Louisiana Regular Legislative Session is over on June 3rd. The State Budget and Capital Outlay (HB2) has passed the House and will be taken up in the Senate after the Revenue Estimating Committee recognizes additional 24/25 current year (HB 782) and FY 25/26 revenues (HB 1).

The legislature is considering calling a limited constitutional convention (HB 800), which could convene concurrently with the current session or in August.

Governor Jeff Landry has pushed the legislature to be bold on several fronts. The upcoming month of session is going to be quite busy with several critical decisions that have yet to be finalized.

Legislative Issues - Session Update

LES has had a very busy session and has clarity and comfort on where several proposed pieces of legislation will land. The subject matters involving civil engineers who practice architecture and universal licensing were heavily debated. I want to extend my sincere gratitude to our organization's leadership for resolving these battles in a way that puts them to bed while fairly resolving our major concerns and maintaining our positive relationships.

HB 713 – Gadberry – Land Surveying – Passed House – Support

HB 794 – Gadberry – Political Subdivision Contracting Requirements – Support

HB 877 – McFarland – Public Contracts with Economically Disadvantaged Businesses - Support

SB 60 – Pressly – Universal Licensing – Neutral position after Senate floor amendments

SB 396 – McMath – Architect Exemption – Neutral position after Senate floor amendments

SB 489 – Cathey – Fire Marshall Removal from Some Inspections – Neutral Position

As my year as the LES State Board President begins, I started looking back at my time in the organization. (Continued) where we encourage students in 6th, 7th, and 8th grades to learn and be proud of their math skills (Objective 3). Some members may also be aware of the LES scholarships awarded each year to engineering students (Objective 3). Less known are the twelve or so awards and honors that LES presents every year (Objective 4).

In my opinion, Objective 1 is the most important objective for LES and is the least known. LES has lobbyists that review all the bills presented for each legislative session, which numbers in the thousands for a regular session. They then send a list of bills that may affect engineers to the LES State Office with a summary of the bill. The list is dispersed to the State Board for our discussion and determination on whether we should support or oppose the bill. Throughout the legislative session the State Board gets updates and requests for calls to action. These calls to action could be in the form of emails or calls to our congressmen or attending a committee hearing. Many times, these calls to action have a short window of time to respond since the legislative session is rather quick paced since so many bills must be acted upon. Due to the response time, the LES State Board reacts for engineers of the state. Sometimes these actions are disseminated to the LES members and other times, we stop a bill, and no one really knows about the possible damage to our licensure being averted. In this legislative session, LES is watching several bills but four very closely. For more information on these bills and other legislative actions, please read Miles Williams' article in this magazine.

Many of the programs that LES institute are paid for through voluntary contributions on your membership renewal. Without these donations, the programs will suffer. In 2023-2024, LES only received donations to issue one \$750 scholarship. Thankfully, the Louisiana Engineering Foundation through their endowed scholarship program was able to issue approximately 35 scholarships. Some of our chapters also have scholarships they award. We would like to continue this program but need your assistance. Mathcounts always needs volunteers and monetary assistance for the state program and to send a team to the national competition.

I highly encourage you as members to get involved. Get your coworkers involved. LES is your voice at the state level. We represent you. The more members we have and the more involved you are, the better representation you have. I, as the incoming president, want to know what we can do better to assist our engineers.
